State of the Association, 2017 Winter Board of Directors Meeting and 2017 Annual Membership Meeting

Even with one of the worst sales seasons for seed wheat in recent memory, MCIA was able to post a modest profit of \$13,236.17 for FY2016. Acreage enrolled in MCIA programs increased 6,262 to come in at 66,190 while tagging volume increased 43,910 to 709,044 units. The seed lab was able to operate at a break-even level and revenues from contract services and outside auditing projects remained relatively stable. Looking ahead, MCIA's Board of Directors approved a budget for FY2017 that projects a small profit with no increase in fees and set the timing for the 2017 annual membership meeting for early August. Keep watching future issues of the newsletter for details and an exact date.

Soybean Quality Update

MCIA's seed testing laboratory has completed analysis on 1,887 soybean samples with an average germination of 92.73%, down significantly from the 2,321 samples tested at the same time in 2016. Germination averages remain relatively stable and many conditioners have finished or are close to finishing their 2016 production, well ahead of the pace in most years. Please feel free to contact the MCIA office if you have questions or concerns with regard to the quality of your 2016 soybean seed production.

2017 Small Grains Application Request Due Date

Field inspection request applications for small grains and cereal crops are due at the MCIA office on April 15. Everyone that has requested inspection for small grains/cereals in recent years should have already received the application forms. If you have not already done so, please submit your field inspection request applications, along with the required seedstock verification and mapping information, to the MCIA office ASAP. MCIA will accept late applications after the deadline, however, priority for inspection will go to those producers that submitted their applications by the due date. At this point, the condition of the crop appears to be good in most areas. With that said, please remember that all fields may be cancelled without penalty up until the time of inspection. Please feel free to contact the MCIA office if you have any questions regarding the application process or the status of your 2017 wheat production fields.

REMINDER – RoundupReady® Soybean Patent Expiration and New Generation Glyphosate Tolerant Soybean Varieties

As we move into the second full production season of off-patent glyphosate tolerant soybeans, there continues to be a lot of discussion and confusion as evidenced by the many calls into the MCIA office inquiring as to the legality of planting saved glyphosate tolerant soybean. As we have communicated many times before, there is no one correct answer to the question of planting saved seed. What is certain is that patent protection for the original glyphosate tolerance trait in soybean has expired and will no longer be enforced.

Producers should be aware that expiration of the glyphosate tolerant trait patent does not automatically mean that all (or any) glyphosate tolerant soybeans will be legal to save and use for seed. First, you must differentiate between the original RoundupReady® trait and subsequent technologies such as Genuity RoundupReady 2 Yield®, Xtend and others that still have trait patent protection. Second, just because the trait patent has expired doesn't mean there aren't other patent protections in place for the variety itself or other components.

Monsanto has established a website that addresses this matter and provides a lot of basic information for producers to use when attempting to determine whether or not a particular variety of soybeans is covered by a patent. To access this site, please visit www.soybeans.com.

2017 LibertyLink® Herbicide Inspection Protocol

All production fields for commercial seed of LibertyLink® soybean varieties must comply with the quality assurance criteria contained in the Bayer CropScience LibertyLink® Soybean Quality Assurance and Stewardship Manual. There have been changes with regard to the requirements for herbicide application and trait expression verification for 2017 production. These changes were distributed to licensed seed producers in early January. Please contact the MCIA office or your Bayer trait representative if you have not received this updated information. Of particular note is the requirement that all production fields of relative maturity 3.5 or later must be inspected to confirm that at least 98% of the soybean plants are tolerant. Bayer recommends, but does not require, that production fields of relative maturity earlier than 3.5 be inspected to confirm that at least 98% of the soybean plants are tolerant.

MCIA is once again assisting Bayer licensed seed producers with this portion of their quality assurance criteria. MCIA inspectors are available to assist with the herbicide tolerance evaluation inspections and file the reports or producers may perform the inspections themselves for those varieties that require a post application inspection. MCIA has a supply of Bayer approved herbicide tolerance evaluation report forms for producers that will be performing their own inspections. These forms contain instructions and procedures for conducting the inspections and reporting the results. If producers want MCIA inspectors to perform the inspections, field inspection request applications will need to be submitted immediately after planting of each production field. Additional information regarding this service will be provided in separate mailing to those companies identified as producing LibertyLink® soybean seed. Missouri Crop Improvement / Missouri Foundation Seeds 2017 Wheat Plot Tour – June 8 in Columbia, MO
